2027 Membership Commitment Bonus

The six complimentary passes are valid for 18 holes of golf with a cart during the 2027 golf season, subject to tee-time availability and applicable Lake Shore guest-access policies, and have no cash value.

Memberships completed after December 31, 2026 are not eligible for the 2027 Membership Commitment Bonus. The six complimentary golf passes and \$100 Pro Shop Credit are available only to qualifying current and new members who complete both requirements by December 31, 2026.

Both memberships must be active and in good standing for referral credits to be awarded.

Golf Cart Safety

All privately owned golf carts must meet Lake Shore Yacht & Country Club safety requirements and may be inspected by Club Management before approval. The Club may deny or revoke Trail Pass privileges if a cart is unsafe or operated in violation of Club policies.

Membership Agreement

By signing this application, I agree that membership is a twelve-month commitment beginning upon Club acceptance. Dues and fees are non-refundable unless approved by Club Management.

I agree to pay all dues, cart or trail fees, assessments, food and beverage charges, merchandise charges, guest fees, and other charges placed on my member account.

Past-due accounts may be subject to late fees, finance charges, suspension of charging privileges, suspension of golf or membership privileges, and collection action. Returned checks, returned ACH payments, or declined cards may be assessed a \$35 fee or the maximum allowed by law. Resignation must be submitted in writing and does not remove obligations already incurred.

Golf Course Access & Outside Play

Lake Shore Yacht & Country Club is committed to providing a private-club experience, with member access as a priority. Membership does not guarantee exclusive use of the golf course. Club Management reserves the right to permit limited outside play, golf outings, leagues, tournaments, and other events when appropriate to support Club operations. Outside access will be managed with consideration for member access and the overall member experience.

Collections

Members whose accounts become delinquent may be referred for collection. The member agrees to pay all reasonable costs of collection, including attorney fees, court costs, and collection expenses to the extent permitted by applicable law.

Members agree to follow all Club Rules, Golf Policies, Dress Codes, Cart Rules, Guest Policies, and operating procedures. Club Management reserves the right to amend Club Rules, policies, procedures, fees, and assessments as reasonably necessary for Club operations. Annual membership dues and membership categories are established by Club Management and are subject to change for future membership years. Members and guests assume the risks associated with golf and Club facilities. The Club and Engle Golf Management, LLC, are not liable for injury, theft, or property damage except as required by law.

Member Code of Conduct

Members are expected to act in a respectful, courteous, and sportsmanlike manner while on Club property. Members are also responsible for ensuring that their family members and guests follow Club Rules and policies.

Lake Shore Yacht & Country Club may suspend or terminate membership privileges for conduct deemed detrimental to the Club, its employees, its members, or its facilities.
